### How to submit a *Delta Magazine* wedding announcement

- Print and fill out this form to mail or scan and email.
- Type announcement in a Microsoft Word document. It must follow *Delta Magazine's* format. Email [weddings@deltamagazine.com](mailto:weddings@deltamagazine.com) to request samples to follow.
- Submit 2 or 3 traditional, vertical digital photographs (high-resolution, at least 300 dpi) of the bride and groom taken by a professional photographer, which can be emailed. If needed, we will accept CD, DVD or jump drive (to not be returned). One photo will be chosen by *Delta Magazine* editors. If submitting via email, please put name of the wedding (bride/groom) in the subject line. If choosing the full page option, please include an additional photo of the wedding party (see below).
- Include payment by check made payable to *Delta Magazine* or credit card. Once we have received a hard copy or emailed copy of this form, you may pay by credit card over the phone by calling Holly Tharp at (662) 843-2700.
- Limit submission to 5 photos.

STYLE SHEET: Spell out the word junior, which is lowercase, and place a comma before and after it. Example: Joseph Patrick Johnson, junior, of Greenville. If the wedding was in Mississippi, use the city only.
